Background

The workshop will examine the commercial opportunities arising from NDA. MOD and other sites.

It will begin by considering the planned spend on cleanup and decommissioning projects. It will then look at the specific types of work in the areas of contaminated land management and the management of clean, exempt and low activity wastes.


Moving on to how future work is likely to be structured, the workshop will explore how contracted projects will be packaged or bundled, the role of joint ventures and contract types/ fee structure. We will ask how the sharing of innovation will occur, whether the supply chain is up to the challenges and how it might need to adapt?

An understanding will be sought of the respective proportions of fixed-cost, shared-risk and framework agreements as well as the proportion of work to be placed by contractors with their affiliate organisations.

Supply chain communication and contract management procedures are also of interest. We will therefore look at how higher level contractors plan to keep their supply chains informed of developments, lead-in times and how projects will be advertised. We will also investigate contract management procedures, including who's who within the contracting organisations.

Finally competition aspects will be considered and best value (versus lowest price) and tender evaluation criteria discussed.

Through the workshop you will have the opportunity to equip your company to deal with contracting, procurement and competition issues.
